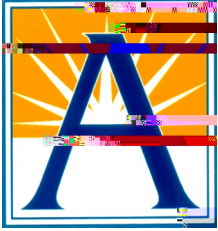
On July 31, 2023, the above cited Contract between your firm and Arlington County School Board, hereafter referred to as APS, expired.
